Fundraising

It was mission accomplished in December as DEBRA announced that it had successfully achieved it's A Life Free of Pain £5m fundraising target.



There are many DEBRA fundraising activities throughout 2023 that have contributed to this result including activities this quarter such as the Butterfly lunch, Dinner with Graeme Souness and Richard Corrigan, the Fingal Lunch and Fight Night, which raised a combined £260k and the DEBRA Christmas appeal featuring the Knight family from Newquay which raised over £28k.

There are so many people across the UK and beyond who played their part this year and the DEBRA Board of Trustees would like to pass on their sincere thanks to all who have contributed, whether that is supporters, members, staff, or volunteers, we couldn't have done it without you.

Not only has the appeal been successful in raising funds to help accelerate DEBRA's drug repurposing programme, but it has also raised much needed public awareness of EB and DEBRA, and crucially brought new members of the EB community to DEBRA, so that they can also benefit from the support and services that the charity offers.

There is still much to do but thanks to the support received this year we have started our drug repurposing journey. We must now continue this momentum into 2024 and beyond.

Awareness

Also, during EBAW, DEBRA President, Simon Weston CBE, Vice President, Graeme Souness, and DEBRA member, Andy Grist were back on the airwaves conducting a series of radio and TV interviews to help raise awareness of EB and DEBRA.

During the week interviews held on channels including TalkSport, BBC South and BBC local radio reached a combined audience of over 6.3m and not only raised much needed awareness but also generated more donations towards our A Life Free of Pain appeal.

Research

In December DEBRA was delighted to announce that it had extended its research programme to include a further 14 research projects.

In response to an open call to researchers in the UK and around the world, DEBRA received close to 30 applications and awarded funding to seven exciting new projects (worth up to £200,000 each) that will run for 2-3 years, five small grants (worth up to £15,000 each) to fund single-year projects, and our first two non-clinical PhD students (up to £140,000 each) which will bring new researchers into the field of EB.

Campaigning

In the last quarter we have continued our government lobbying journey with productive meetings held with the health ministers in both England and Scotland - Minister of State for Health and Secondary Care in England, Andrew Stephenson CBE, and Minister for Public Health and Women's Health in Scotland, Jennie Minto MSP. The DEBRA team also met with Michael Gove, Secretary of State for Levelling Up, Housing and Communities, and Minister for Intergovernmental Relations.

In these meetings the team from DEBRA covered several topics including the need to establish an EB population register using the data held within NHS Scotland in a similar way to what we are doing with NHS England, so that eventually we have data that covers the entire UK EB population. The team also shared an update on the progress that we have made with our drug repurposing programme, including our first clinical trial with apremilast, and spoke about some of the challenges we are facing such as getting clarity over the clinical trial requirements for EB and how to get the drugs approved in the NHS.

Whilst we haven't got answers to all our questions yet, the dialogue we are having in these meetings is very positive and we look forward to continuing this dialogue and hopefully getting some firm actions agreed in the new year.
